Presentation 1 – Impact of Social Media on children, Warning Zone, Greg Johnson

- 1. Where does the funding for home educated children come from?

 Cost is £14 per pupil to attend Warning Zone. This is funded by the parents.
- 2. Is there a cost associated for visiting secondary schools?

 Warning Zone can visit schools and present to whole year groups –

 Information for Secondary Schools Road Crew Warning Zone
- 3. Can primary schools visit? Yes, year 6 pupils aged 10-11.
- 4. Do your team come to supported accommodation for 16 to 25 years? Warning Zone is aimed at year 6's only and Roadcrew 12-15 year olds. However, we are looking at how we can widen this out in future. Warning Zone is based in Frog Island, Leicester. Please follow on Social Media pages for updates (Facebook and LinkedIn).
- 5. Do you welcome families? Warning Zone is aimed at under 16's via schools and home schooling. We don't currently have a family provision.
- 6. I work with adults with learning disabilities. Would any of the work you do be suitable?
 - We do occasionally do adult disability sessions. These are ad-hoc reactive sessions to enquiries. Feel free to contact us if you'd like to explore this further.
- 7. How do we make a referral to Warning Zone / How do you refer is it just through schools?
 Schools / Home schools can call Warning Zone to arrange a trip: Arrange A Visit Warning Zone

8. I guess this does not relate to Preschoolers?

Warning Zone is aimed at year 6's initially (age 10-11), with option of follow up year group sessions for year 9-11 via our Roadcrew offering.

Presentation 3 – LLR SCP Self-Harm and Suicidal Behaviour procedure, Claire Turnbull

1. Is it possible for Education to make a CAMHS crisis referral?

See pathway in Practice Guidance pages 15 and 16 – there is the CAP helpline for mental health advice. If there is a high risk of suicide, the referral would be to Social Care. In an emergency, call 999.

Section 4 of the Procedure – discusses CAHMS service and a discussion before referral and: "Where there are serious concerns and an urgent mental health response is required, a referral can be made to the Crisis Resolution and Home Treatment team which provides rapid assessment and management for child and young people with a mental health crisis (including self-harm and suicide or any other escalating risk where without intervention, hospital admission or health related residential placement would be required)."

2. Can I ask about historical self-harm and suicidal thoughts if mentioned by client as of today?

3. Will there be any info relating to adults with disabilities and learning disabilities?

I will check with my Adult Safeguarding Lead as to where to link you to re policies. There was nothing specific about suicide but there is detail about MCA and a person with learning disabilities potential to be coerced into suicide.

4. Where are the letter templates found please?

The individual schools should add the key information to the letters to parents that I mentioned in my presentation. Within the Task and Finish Group that amended the procedure and Practice Guidance, the Local Authority Leads for Education were involved. The DSL for the school should be aware of the information on letters sent to parents and carers of excluded children. If you come across difficulties, let me know and I will link with the LA Education Leads.

- 5. Does this only apply for staff? can I use this for other children that I am in contact with such as my own nieces and nephews?

 This is Practice Guidance and Procedures for practitioners but the principles of talking to a child or young person would be the same. If you were a relative or a friend, you would access services and support from that perspective in relation to how to access services. But ensure that is the role that you are taking not as a practitioner.
- 6. Can GP help you regarding this matter if you have your own child? You should be able to get support from your GP. It would be worth considering aspects of confidentiality and consent depending on the age and Gillick/Fraser competence of the child or young person and the GP may want to speak to the young person alone. It could be worth contacting the CAP helpline with concerns or accessing the support agencies listed in the Practice Guidance.
- 7. Is there similar available for Adults and Adults with a Learning Disability? See the answer to Q3.
